



An example of how a house or property clearing can be complex.

I know many of our readers like to hear about our experiences or “stories from the far side”, as one of our friends puts it. I know I have mentioned this before, but we do need to be cautious as we do not want to identify any of our clients. This does limit us as to what we can describe. As we are routinely asked for help in [clearing a house, property or business](#), I have added this case file from one of our most notable experiences. Hopefully it will give you an idea of how this type of service is not always straightforward.

We were approached by a client to investigate some occurrences in a business premises. The “feeling” in the building had developed to the point of being very unpleasant and staff, at the end of their shift, could not get out quick enough; incidents of crockery being moved were also common. This was an established business but with a change of ownership. On investigation, people who had previously worked in the building acknowledged they had felt some energy or presence but did not consider it disturbing. So what changed?

Basically the new owners had introduced another energy that aggravated or excited the existing disturbance to the level of causing mayhem and menace. When Chris and I investigated, we discovered a nearby portal that was affecting the energies around the building. The energy flow of the portal had been corrupted in some way and was also impacting on the [traditional custodians of the land](#), in Spirit. A human spirit was also resident in the building and could only be described as “psychotic.” How or why it was in that position we do not know. The element that really kicked off the mayhem was some unbalanced energy attached to a staff member. Thus, a combination of imbalances including the portal energy and a disturbed human spirit, set the formula for some interesting experiences by the staff. Smudging proved to be of little help. Most of what I have described is fairly routine stuff; it was in dealing with the individual and attached energy that it became interesting.

In order to achieve a safe and balanced, working environment we had to deal with three separate aspects. First the portal had to be balanced and moved to another plane so that it did not impact on any other beings, whatever dimension they may be on. This was completed with the permission from the traditional custodians. Then we had to deal with the attached energies before we could release the human spirit from the building. With Chris on the table we used a surrogate technique to deal with the energies attached to the staff member. It was hard going and we eventually realised that we were dealing with some very ancient knowledge and energy that had been corrupted in some way. This was an imbalance coming down [the genetic hereditary line](#) on the Fathers side. This was indeed a very ancient lineage and we found ourselves going back to the dimension of Easter Island. Poor Chris could not stop her lips pouting and forming into the shape we have all seen on Easter Island statues.

Initially it was a very frustrating and challenging process to understand what was happening and what was needed to restore balance. For want of a better term I'm going to describe the lineage or ancestors we were dealing with as the "Ancient Ones." These ancient energies were not prepared to work through a woman and that's why we were having so much difficulty. So we had to reverse roles and I climbed onto the table to be the medium, while Chris helped to conduct the proceedings. From then on, the pieces started to fall into place.

Sometime in the past, external beings had managed to infiltrate the ancestral line to gain and manipulate the ancient knowledge. This had the potential to affect everyone down the line and interfere with those around them when the right conditions prevailed. At least that is my interpretation and I'm not allowed to give any other details. We worked to clear the ancestral line of unbalanced energies for the benefit of everyone connected to it. Once this was done it was then possible to deal with the human spirit as the major disrupting energy affecting it had been cleared. Again I do not want to give any further details here except to say that the human spirit was returned to the traditional custodians for healing.

This work as a whole was a new experience for us. When we were having difficulty understanding what we were to do, we called on assistance from our usual sources for guidance, but it was of limited help. My limited understanding is that we were dealing with different realms each with different energies. Each realm could not, or would not, encroach upon the other...there was no, one single overriding hierarchy. I have to admit that I don't fully understand it. It's as if we were dealing with a Spirit realm with a High Council of hierarchy, an angelic realm with Ascended Masters and then a separate realm of the Ancient Ones. No doubt that is a very crude interpretation on my part, and I'm sure every realm and being was working for a positive outcome. But it did seem Chris and I were stuck in the middle fumbling around in the dark to a certain extent.

So now you may have an idea why clearing a home or property is not always straight forward and simply smudging with sage, can at times, have little effect. It pays to investigate before making assumptions or jumping straight into an energetic clearing.
